We are in the "555 Twelfth" building, which is the two-story beige office building with the fountain out front that is part of the Pompano Business Park. If you are using an online mapping system for directions, use 555 S.W. 12th Avenue as the address to search.

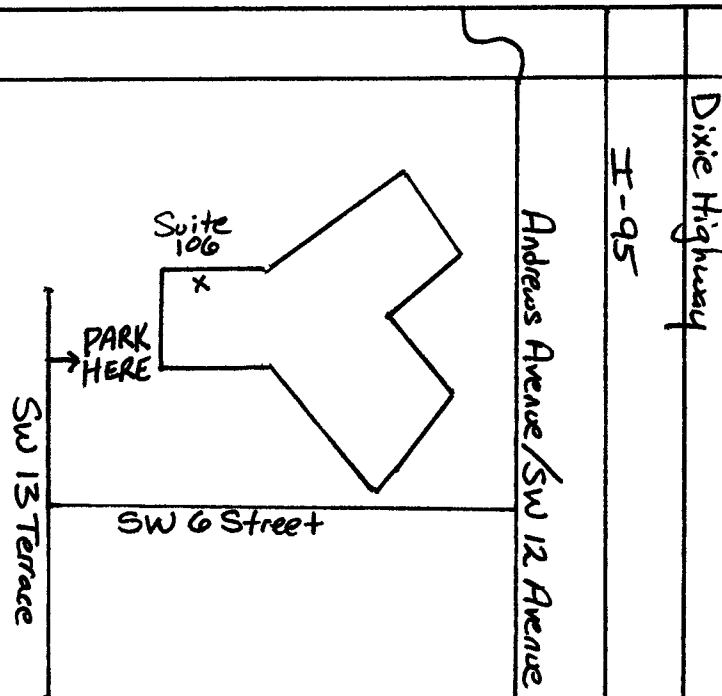
Directions to our office:

1. Proceed South on Dixie Highway to S. E. 3rd Street
2. Turn Right onto S. E. 3rd Street (passing over I-95) and proceed to the first traffic signal, which will be S. Andrews Avenue
3. Turn left onto S. Andrews Avenue and proceed South approximately .2 miles to S. W. 6th Street
4. Turn right on S. W. 6th Street and proceed to stop sign at corner of S. W. 13th Terrace.
5. Turn right onto S. W. 13th Terrace and turn right into the first driveway on the right. Park anywhere.
6. Our suite, #106, is located toward the back (west) side of the building. Some people have trouble finding us – use the map, below, to find us more easily. If you do have trouble finding us, please do not hesitate to call for directions: (954) 782-2660.
